ELIGIBILITY: Open to 2023 USA Swimming members, NO ON-DECK ENTIREES. Registration application **must be received by the meet entry deadline** by meet processor, administrative referee, or SCS Office. Late application will be considered "on-deck" subject to penalties in SCS Swim Guide, Part One, III, B. Registration application may be submitted with entry form. In SCS age group meets, swimmers 18 & younger must prove birth dates prior to competition. **ALL athletes 18 years and older must complete the free online ATHLETE PROTECTION TRAINING course to be cleared to compete.**

POOL: SANTA CLARITA AQUATIC CENTER, 20850 CENTRE POINTE PARKWAY, SANTA CLARITA, CA 91350. 14 FWY N Take Golden Valley exit left to Centre Pointe Parkway. 14 FWY S Take Golden Valley exit right to Centre Pointe Parkway. Outdoor 50 meter x 25 yard with 10 competition lanes and 9 warm up/down lanes. The competition course has been certified in accordance with 104.2.2© on file with USA Swimming. Pool depth: start 7'6" turn end 7'6".

MEET START TIMES: Preliminary sessions will begin at 8:30 AM. Finals sessions will begin no sooner than 2 hours after the completion of the final heat of the prelims session each day.

WARM-UP PROCEDURE/TIMES: Assigned warm-ups will begin each day at 7:00 a.m. in the competition pool. The competition pool will be closed at 8:20 a.m. with supervised warm-up/warm-down available in the adjoining pool. There will be assigned warm up times and lanes; two warm-up sessions may be used. Warm-up procedures will be posted at the pool. Swimmers must be under the supervision of a USA Swimming member coach during warm ups. All swimmers must use a 3-point slide in entry into the pool for warm up, no jumping or diving.

MEET REFEREE: The Meet Referee shall be in charge of the meet. Any questions regarding the conduct of the meet should be directed to **Wes Jackert, email: wjackert@gmail.com**

RULES: Current USA Swimming Rules, including the Minor Athlete Protection Policies (MAAPP 2.0), will govern the meet. All Coaches and Officials must complete the CDC or NFHS concussion online course. All Coaches and Officials must complete the CAT, and the CANRA Mandatory Reporting Course. Current SCS meet procedures will be in effect and take precedence over any errors or omissions on this form. Swimmers must compete in their own age group. Age on Feb 15, 2025, determines age for the meet. Swimmer must be at least 5 years old on February 15th, 2025. **Maximum THREE events per day (not including finals).** Meet will limit 500 swimmers, first come first serve. The last teams entered may have to trim their roster to meet the limits of the meet. The meet admin does have the right to adjust timelines based upon entries. All prelims heats will be circle seeded and swum fastest-to-slowest. 11-12 500 Freestyle timed finals events will be seeded and swum fastest-to-slowest. The 500 and 400 IM will be seeded and swum fastest-to-slowest, alternating girls and boys. Timers must be provided by each team. Swimmers in the 500 Freestyle should provide timers and lap counters. **The host team reserves the right to flight the meet for the sake of the timeline.**

BONUS EVENTS: Swimmers who qualify for 1 event can swim two (2) bonus events for a total of 3 events. Swimmers who qualify for 2 events can swim one (1) bonus event for a total of 3 events. Swimmers who qualify for 3 events can swim one (1) bonus event for a total of four events. Bonus events chosen must be 200 yards or shorter. All bonus events must have a time. No NT or swim-ups can be entered.

RECORDING DEVICES & MEDIA NOTICE: The use of audio-visual recording devices, including cell phones, are not permitted in locker rooms, changing areas or restrooms. **Recording devices are not permitted behind the**

starting blocks during the starting sequence throughout the meet. This meet may be covered by the media, including photographs, video, web casting and other forms of obtaining images of athletes participating in the meet. Entry into the meet is acknowledgement and consent to this fact.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

RACING START CERTIFICATION: Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

SWIMWEAR: Swimwear must conform to USA Swimming Rule 102.8. Only swimsuits complying with FINA swimsuit specifications may be worn in any USA Swimming sanctioned or approved competition. **TECH WITH BONDED OR MESH SEAMS MAY BE WORN BY 13 AND OLDER.** www.socalswim.org.

DECK CHANGES: Deck changes are prohibited.

CHECK-IN: Coaches will receive a packet with print-outs of entered athletes by day. Coaches will use the list to indicate scratches on a daily basis. Scratches must be turned in to admin by the following deadlines: Saturday scratch deadline=7:30 AM Saturday (one hour before meet start); Sunday scratch deadline=Saturday 5 PM (start of Finals); Monday scratch deadline=Sunday 5 PM (start of Finals).

MAAPP 2.0: Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP2.0"), will govern this meet. Per MAAPP 2.0, sites are supposed to be able to provide separate athlete/non athlete bathrooms.

CHANGE OF AFFILIATION: Before the meet, a swimmer may change affiliation by submitting a **Club Transfer form** to the Swim Office. At the meet, a swimmer may UNATTACH (may not attach or reattach) by notifying the Administrative Referee in writing and paying the appropriate fee.

SUBMITTED/QUALIFYING TIMES: Times submitted must be the **best recorded times** short course or long course from this or the preceding swim season (**NO WORK OUT TIMES**). For seeding purposes only, after entries close Meet Administration will convert non-conforming times. Coaches and swimmers should be prepared to verify all submitted times. Swimmers must have achieved time standards listed for an event. Discrepancies in submitted times could lead to disciplinary action.

ENTRY PROCEDURE: **\$6.50 for each INDIVIDUAL EVENT plus \$15.00 SURCHARGE plus \$7.50 FACILITY CHARGE.** NO REFUNDS. Returned checks will incur a service fee. E-mail entry (entry. zip file) will be accepted ONLY when received with an attached .PDF file **including electronic signature** of coach and will be dated as official at that time. (5PM postmark would queue before a 10PM electronic). Full payment (single team check) for an e-mail entry must be postmarked within 48 hours of the e-mail entry. Failure to comply will be referred to the Board of Review. Entry updates (added events) will be processed when received by the processor by the entry deadline. Added events (entered swimmers) may be submitted by hard copy (this includes e-mail) ONLY. Prior to entry deadline new swimmers accepted SPACE AVAILABLE. DO NOT RESEND AN ENTRY FILE. A replacement file for the team will not be processed. **Deletions will not be refunded. IF THE MEET FILLS PRIOR TO THE DEADLINE, ENTRIES WILL BE REJECTED (LAST RECEIVED, FIRST REJECTED).** To avoid concern regarding receipt of entry card the designated address, enclose a stamped, self-addressed envelope or postcard. **(Receipt of entries will not be verified by phone or e-mail.) Coaches entering any qualified Outreach athletes in this meet, must notify the Meet Admin when sending their team entry report and file, listing the athletes name. The Outreach athlete entry fee is \$15.00 flat fee.**

ENTRIES CLOSE: ENTRIES MUST BE RECEIVED BY THE MEET PROCESSOR NO LATER THAN 5 PM, WEDNESDAY, FEBRUARY 5th, 2025.

SCORING/AWARDS: MEDALS 1st– 8th, the following age groups will be awarded: 7-10, 11-12, 13-14, 15 & Over.

FINALS: A championship final, 10 swimmers (1-10) will be offered for 7-10, 11-12, 13-14, 15&Over age groups will be top 20 with a consolation heat and final heat. **The national finals' scratch rule will be used. SCRATCH FOR THE FINALS:** A swimmer must scratch or place an intent on an event within 30 minutes of announcement of preliminary results. Final "no--show" (original top places only) except last day will be removed from their next event of the meet. A \$50.00 fine will be assessed to the swimmer for a no show in her/his last event of the meet.

It is understood and agreed that by committing to this event USA Swimming, Paseo Aquatics, Inc., Paseo Aquatics Sports LLC shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

USA SWIMMING MEET 360/MAAPP:

USA Swimming Meet 360:

- Permanently suspended or ineligible individuals cannot be present on deck, coach, or perform any function at a meet requiring USA Swimming membership.
- During registration, ensure all coaches, officials, trainers, massage therapists, LSC or host club staff, and medical professionals show proof of current USA
- Swimming membership (e.g., require them to show their Membership Card via the USA Swimming app) at registration. If such an individual cannot demonstrate
- proof of membership in good standing, deck access will not be granted.
- Individuals permanently suspended or ineligible can be spectators at a meet and may be in the stands.
- Violators shall be reported to the Meet Director or Meet Referee, who can then direct that individual to the spectator area. A subsequent report should also be
- made to USA Swimming.
- A quality control system has been implemented to ensure that individuals who are ineligible for participation are unable to participate in this competition.
- Additionally, all adult members of USA Swimming who have not completed their Athlete Protection Training will not be able to participate in this competition.
- Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of
- child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport may be made via telephone at 833-5US-SAFE (833-587-

- **Medical Emergency:** Call 911

Life Safety

- **Earthquake:** Adhere to facility emergency procedures. Notify lifeguards. Notify all occupants to clear pool immediately. Call 911 if needed. Evacuate all persons in attendance to parking lot or front lawn away from all buildings. Contact all teams and request an accountability check.
- **Weather Emergencies:** Notify lifeguards. Notify all occupants to clear the pool immediately. If lightning in the area, all occupants must leave the pool and the deck for at least 30 minutes after the last lightning strike in the area.
- **Fires:** Call 911. Clear the pool immediately. Evacuate all persons in attendance to parking lot or safe area outside of structure. Contact all teams and request an accountability check. Await emergency response outside structure and report to responding personnel if all persons are accounted for.
- **Hazardous Materials:** Call 911. Notify lifeguards. Evacuate all persons in attendance to a safe area away from and upwind of any hazardous material.
- **Electrical Emergency:** Call 911. Notify lifeguards. Notify all occupants to clear the pool immediately. Isolate the area of hazard and deny entry. Move all attendees to a safe area away from the hazard.
